- B. Our finances are in good shape, with a balanced budget for the current year and a surplus from last year of \$4,500. Enrollment is up to 120 students, vs 101 last year.
- C. Anna Katra headed the outreach committee, which is an ongoing initiative. We attempt to establish public awareness of who we are through word of mouth, community concerts, social media (Facebook), special outreach events and advertisement.
